Grand Lodge of England Celebrates Tercentenary

This year the United Grand Lodge of England (UGLE) is celebrating its 300th anniversary with a year-long festival of events. But before the UGLE was founded, there were individual, local Lodges already in existence.

The questions of when, why and how Freemasonry began are somewhat problematic because some of the most reliable potential evidence has surely been lost to history; for example, minutes and other historical records of some of the earliest Lodges and their members.

The general consensus recognized by the UGLE is that English Freemasonry as we know it today evolved from the organization of operative stone masons who built great cathedrals and castles during the Middle Ages.

One Elias Ashmole made a record of his October 16, 1646, initiation at Warrington in Lancashire, complete with the names of other Freemasons who were in the Lodge at that time. While this is the earliest evidence of an English speculative Freemason, we can clearly infer that at least one Lodge was already operating by that date, with its existing members initiating new members.

On June 24, 1717, four London Lodges, obviously already in existence, met at the Goose and

Gridiron Tavern in St. Paul's Churchyard and declared themselves a Grand Lodge, the first such Grand Lodge in the world.

By 1723 the Grand Lodge had published its first *Book of Constitutions*, was meeting quarterly, keeping records of its meetings, and had extended its authority beyond London.

The Grand Lodges of Ireland and Scotland were founded in 1725 and 1736, respectively, by Lodges already in existence, begging the question of when local Masonic Lodges first began operating in those countries.

Throughout the 18th and 19th centuries Freemasonry spread around the world with the expansion of the British Empire, as warrants (charters) were issued

Appreciated Assets As One-Time Gifts

With stock markets once again approaching their all-time highs, the opportunity to make gifts in the form of appreciated assets becomes more attractive to many donors.

There are various reasons to use appreciated assets to make one-time gifts to an organization such as The Lakewood Masonic Foundation. Chief among them are the sense of personal satisfaction you will achieve from making a special gift and the likely benefit you will receive from the unique tax breaks for this type of gift.

A gift of an appreciated asset often provides you with a greater tax benefit than a gift of cash. For example, a gift of appreciated stock that you have held for more than 12 months can be deducted at its current value if you itemize deductions, and you won't have to pay capital gains tax on the appreciated portion of your gift. As always, you are encouraged to consult with your legal and tax advisors before making a gift of this type.

There are two ways to use appreciated assets—such as stocks, bonds, mutual fund shares, real estate and insurance policies—to make a special gift. One option is to donate the asset outright, meaning that it would be transferred immediately from you to The Lakewood Masonic Foundation. Another option is to fund a lifetime income gift, which will provide you with income for your lifetime or for some other specified period of time. If you prefer to make a more straightforward gift, you may simply write a check using the form in our newsletter (see page 11), by responding to our letter appeals or by adding a donation to your annual dues.

You may designate your gift or bequest to be used for our historic preservation, educational or charitable purposes; split your gift among these purposes; or simply ask that your gift be devoted to our greatest need. All gifts, other than a small percentage spent for printing and mailing, are used for our stated purposes.

Your donation is a special way of showing your love for our Lakewood Masonic Family and for our historic home. Our 2016 Centennial is upon us, and we still have lots of catch-up maintenance to complete on our facilities.

While gifts and bequests may be directed to our Lakewood Masonic Foundation, our Lakewood Masonic Temple Endowment Fund or our Lakewood Masonic Temple Company Operating Fund, please note that only gifts and bequests to our Lakewood Masonic Foundation are deductible for federal income and estate taxes to the extent permitted by law. Gifts to our Endowment and Operating Funds are not deductible; but, depending on your tax situation, deductibility may not be an issue for you.

Master's Message

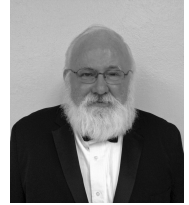

However loquacious a Freemason may be in the natural confidence of neighborhood intercourse, he must be reserved in all that relates to the esoteric concerns of Freemasonry.

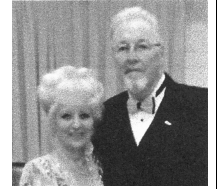

Companions:

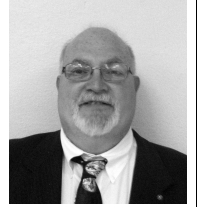

In the Charges compiled from them, approved by the Grand Lodge of England in 1722, and published by Doctor Anderson, it is said "No private piques or quarrels must be brought within the door of the Lodge, far less any quarrels about religion, or nations, or State policy" (*Constitutions*, 1723, page 54).

Fendeurs, Order of

Ordre des Fendeurs et Fendeuses. Also known as the *Forest Masons*. A French Order accepting both men and women as members, though not necessarily connected with the Masonic Fraternity. They traced their Order back to the time of Alexander the Great. They were, in all probability, a branch of the Carbonari, or Charcoal Burners, a political league which made its appearance in the twelfth century. In 1747 there was a revival of this society and it became popular with ladies and gentlemen of high rank and distinction. Meetings were held in rooms decorated to represent a forest, or in the summer time, when the weather permitted, the meetings were held outdoors. In their ritual they used implements connected with wood-cutting, such as axes, logs, tree stumps, stone cups, whistles, and their regalia included a carpenter's apron and a russet-colored sash edged with green. The Master was called *Père Maître* or Parent Master, and the other offices were Cousin Hermit, Cousin Winedresser, Cousin Bear, Cousin Elm, Cousin Oak and so forth. A woman candidate was called a Briquette and a man, Briquet.

Grand Lodge of England Celebrates Tercentenary

to newly formed Lodges by one of the three "Home" Grand Lodges.

In 1751 a rival Grand Lodge appeared in London, formed by Irish Masons who claimed that the original Grand Lodge of England had made innovations in the body of Masonry, something forbidden in the *Charges*. To distinguish itself, the new Grand Lodge called itself the Antients and dubbed its rival the Moderns. The two rival Grand Lodges coexisted for almost 63 years, along with their respective subordinate Lodges, with neither recognizing the other as being "regular."

On December 17, 1813, following four years of negotiation, the two rival Grand Lodges united to form the United Grand Lodge of England. One result was the adoption of standard rituals, procedures and regalia. By 1814 there were 647 Lodges in existence.

Our Grand Lodge of Ohio was formed in 1808, five years after Ohio became a state, with six Lodges then meeting in Ohio. The oldest among them was the current American Union #1, originally a military traveling Lodge which settled in Marietta in 1790. American Union was originally chartered in 1776 by the Provincial Grand Lodge of New England (Moderns), one of the predecessors of the present Grand Lodge of Massachusetts, so it can be argued that the roots of Ohio Freemasonry can be traced directly back to the UGLE. The other five Lodges were variously first chartered by the Grand Lodges of New Jersey (via Kentucky), Connecticut, Pennsylvania and Massachusetts.

Our own Clifton-Gaston Allen Lodge has indi-

rect connections to two of the three so-called Home Grand Lodges via its two sister Lodge relationships in Canada. Trinity Lodge #521 of Windsor, Ontario, is the result of a consolidation of three Windsor area Lodges, one of which was Clifton Lodge's original sister Lodge, Dominion #598, chartered by the Grand Lodge A. F. & A. M. of Ontario under the tradition of the English constitution. Gaston G. Allen Lodge's original sister Lodge, St. John's #209a of London, Ontario, was originally chartered under the Irish constitution. Historic in their own right, Trinity and St. John's Lodges recently celebrated their 100th and 175th anniversaries, respectively.

Our own Lakewood Masonic Family bridges the century mark. Lakewood Lodge #601 F.&A.M., chartered in 1908, and Cunningham Chapter #187 R.A.M., chartered in 1910, have celebrated their centennials. Soon approaching are the 100th anniversaries of Clifton-Gaston Allen Lodge #664 F.&A.M. (1920), Holy Grail Commandery #70 K.T. (1920), Cleveland Assembly #15 S.O.O.B. (1921), Lakewood Council #125 R.&S.M. (1921) and Ann Rutledge Chapter #453 O.E.S. (1921).

But what of us? We continue to make our own history, but only with the loyal support of our members. Masons and Eastern Stars alike must continue to live up to the responsibilities of membership. We will always need new members and new officers to take over from those who have preceded us. We must continue to provide the financial support needed by our Masonic organizations, our Masonic charitable works and—yes—our own Lakewood Masonic Temple and Lakewood Masonic Foundation. 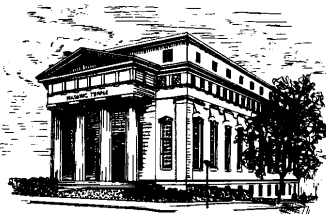
